

# Kyoto Tanba Triathlon Competition in Nantan

## Written Participation Pledge

If I am accepted for participation in the 4th Kyoto Tanba Triathlon in Nantan (hereinafter shortened to "Triathlon"), I pledge to participate in the Triathlon understanding and agreeing with the following matters.

1. I pledge to follow all of the rules, regulations, and instructions established by the Triathlon sponsor, and take caution to manage my own safety and health under my own responsibility in participating in the Triathlon, and if I feel unwell or otherwise abnormal I pledge to promptly withdraw from the competition.
2. I understand that the Triathlon competition is a rigorous competition. Therefore, in the case of any injuries suffered during the competition or incidental activities as well as resultant after-effects or accidents resulting in death, etc., I and my family, representatives, guardians, and other related persons will exempt the sponsors and all other persons affiliated with the Triathlon from any responsibility except for the Triathlon accident insurance benefits, regardless of the cause.
3. I pledge that I am in good physical condition and have engaged in sufficient training in preparation for participation in this competitive Triathlon. Furthermore, I pledge that the results of a physical examination by a physician assure my health.
4. If I am injured, have an accident, become ill, etc. during the Triathlon competition or incidental activities, I do not object to receiving appropriate treatment.
5. I consent to the use of video, photos, reports, records, names, ages, and addresses (country, prefecture, city, town, and village names), etc. related to the Triathlon on television, in printed material such as newspapers and magazines, and on the Internet, and I grant publishing rights and the rights to use my likeness to the sponsors. I consent to commercial use in printed material, photos, DVDs, information media, etc. which are created incidentally by the sponsors.
6. I pledge not to demand any expenses required for participation in the Triathlon including the application fee I paid in cases where the competition contents are changed or canceled due to poor weather conditions or a poor competition environment such as roads.
7. I pledge that all matters listed in all submitted documents such as my application for this Triathlon are true and accurate. I also pledge that my family, representatives, guardians, and/or other related persons have clearly understood and agreed to the contents of the Triathlon and this written pledge.
8. I will take full responsibility regarding my personal possessions and exercise equipment during the Triathlon competition and incidental activities.
9. I pledge that I possess a sufficient understanding of Triathlon manners.
10. I pledge to adhere to the deadlines for submission of documents, remittance of application fee, etc.
11. I agree that I will be restricted from participation if I engage in any of the following acts.
  - Those whose applications or other submitted documents are found to contain false information
  - Those who use abusive language, behave violently or rudely, commit unpleasant acts toward citizens, Triathlon staff, Marshalls, volunteers or other Triathlon officials, acts which obstruct the administration of the Triathlon, or other acts of nuisance and do not correct this behavior even after being warned by the Triathlon head office
  - Those who commit acts deemed to be cheating or violations of manners (intentionally failing to pass through measurement points, drafting, etc.)
  - Those who do not follow the Triathlon schedule such as the reception time, bike deposition/hand-over time, etc. and Triathlon requirements
  - Those who improperly transfer or receive participation qualifications to or from another person
