If I am approved to participate in the 40th All Japan Triathlon Miyakojima (hereinafter referred to as "the competition"), I hereby pledge to do the following:

- 1. I pledge to follow the rules, regulations, and instructions established by the organizer, to take personal responsibility for my own safety and health, to participate in the event, and to promptly withdraw from the competition if I feel any health problems.

Therefore, in the event that I suffer an injury or permanent injury, or suffer death or any other accident during the competition or incidental events, regardless of the cause, I and my family representatives, guardians, and other related parties release the organizers and all other parties involved in the event from all liability, except for insurance benefits under the Event Accident Insurance policy. I hereby release the organizers and all other persons involved in the event from any and all liability to the organizers and all persons involved in the event, regardless of the cause.
- 4. I certify that I am in good health and do not anticipate any problems with my participation in the competition. I further swear that the results of my medical examination by my physician assure me that I am fit enough to participate in this competition.
- 5. I have no objection to appropriate treatment being taken against me if I am injured, have an accident, or become ill during the competition or incidental events.
- 6. I understand that my name, age, address (name of country, prefecture, or city), name, photograph, article, record, name, and other information related to the competition may be used on television, newspapers, magazines, and other printed media, as well as on the internet, and that I entrust the organizer with the rights of publication and portrait. I authorize the organizer to use my name, age, address (country, state, province or city), etc. in printed matter, photographs, DVDs, and information media for commercial purposes. approved.
- 7. I pledge that if the competition is changed or canceled due to poor weather conditions, poor road conditions, public health risks, or other force majeure, I will not be liable for any expenses incurred in participating in the competition, including the registration fee I have paid.
- 8. I pledge that all information entered in this competition, including application information, is true and accurate. Also, I, the representative of my relatives, parents, and other related parties, pledge that I understand and accept the contents of the competition and the written pledge.
- 9. I pledge not only my ability as an athlete and finisher, but also my good manners as a triathlete.
- 10. I pledge to abide by the deadlines for application and payment of participation fees.
